A guide for parents of Cambridgeshire children starting secondary school in September 2023

This leaflet explains how to apply for a secondary school place if your child lives in Cambridgeshire and was born between 1st September 2011 and 31st August 2012.

Application deadline 31 October 2022

All the information you need to apply for a secondary school place, will be available on our website Secondary school admissions - September 2023 - Cambridgeshire County Council

www.Cambridgeshire.gov.uk/admissions

The benefits of applying online are:

- it is quick and easy to do;
- the system is secure;
- there is no risk that your application will get lost in the post;
- you can change / amend the details on your application up until the closing date;
- you will receive an email confirmation when your application has been received, and each time it is resubmitted;
- it is available 24 hours a day, 7 days a week up until the closing date of 31 October 2022 (except during periods of essential maintenance)

Alternatively, you may apply using a paper application form. A copy of the admission guide and application form can be requested from any Cambridgeshire primary school or by contacting the admissions team below.

Monday to Thursday 9:00am - 5:00pm Friday 9:00am - 4:30pm

All applications are considered equally, whether online or on paper.

Therefore you should not apply twice.

Key facts about the application process

What do I have to do?

You should select up to three schools in order of preference.

To help you make this decision you can:

- find your catchment area school online at http://my.cambridgeshire.gov.uk;
- · find other schools in your area by looking directory on the website;
- · read the oversubscription criteria for the schools you are interested in;
- arrange to attend the schools' open events;
- look at other sources of information like the school prospectus and website;
- consider the home to school transport policy on our website, and whether you will qualify for free transport to any of the schools you list on your application form.

You must make an application by 31 October 2022.

- It is vital that you apply by the closing date. Applications which are received after the deadline will <u>not</u> be processed until after the national offer date of 1 March 2023
- Applications can be made either online at <u>Secondary school admissions September 2022 Cambridgeshire</u>
 <u>County Council</u> or on a paper application form available from any Cambridgeshire primary school or by contacting the Admissions Team.
- If you are applying for St. Bede's Inter Church School, make sure you also complete the school's supplementary information form (SIF) and return it to the school by the closing date, otherwise your application will not be processed under the school's faith-based criteria.

What happens next?

We will offer your child a school place on 1 March 2023.

- If you applied online and requested confirmation by email, you will receive an email on 1 March 2023 informing you of the school you have been offered.
- School offer letters will be sent by second class post, despatched on 1 March 2023, to everyone who
 applied before the deadline, whether you applied on paper or online
- If we are unable to offer your child a place at any of your preferred schools, we will offer a place at the nearest designated school.

What happens if I am not offered the school I want?

- Your child's details will be added to the school's reserve list in case a place becomes available and will be held on this list until 31 December 2023.
- You can ask about other schools that have places remaining, and submit a new application requesting alternative school preferences.
- You can request an appeal. For further information see https://www.cambridgeshire.gov.uk/residents/children-and-families/schools-&-learning/apply-for-a-school-place/admission-appeals/

Useful Information

Important

- There is no automatic transfer to primary school so an application to the local authority is required in ALL cases.
- If you fail to make an application for your child's place before the deadline an offer of a place will not be made for your child on 1 March 2023. This may have a severe and negative impact on your chances of securing a place at your preferred school.
- If you are applying for a secondary school which requires a completed SIF, you must ensure that you complete a Supplementary Information Form (SIF) and a Local Authority Application Form.

Considering a school

- Find details of a school's profile, Ofsted report and performance data at http://schoolsfinder.direct.gov.uk/
- Make time to visit the school.
- Do not judge a school by what others say.
- Think about transport and how your child will get to school.

Allocating school places

- All applications received by the deadline are considered at the same time, no school offers are made on a "first come, first served" basis and priority is **not** given to those who put the school as a first preference.
- Decisions about who to offer school places will be made solely using the oversubscription criteria for that school, no other information is taken into consideration.
- All your preferences will be considered. The order in which you list the schools will be used if you can be offered a place at more than one school. In this case, you will be offered the school which you put as the highest preference.

Use your preferences wisely

- Use all three preferences available to you and be realistic about the schools you apply for.
- List your school preferences in the order that you would most prefer them, not the order you think you might get them.
- You are advised to name your catchment school as one of your preferences.

Reminder

If you apply on-line and re-visit your application to view and make changes you **must** ensure it is re-submitted before 31 October 2022

Naming a school

- Naming more than one school will not weaken your chance of gaining a place at your first preference school.
- Naming the same school more than once will not increase your chance of gaining a place.



Swallows

This week in Swallows, the children have been working incredibly hard in their English lessons writing their adventure stories. The children have been writing stories based upon a journey through a wild forest. They have been including direct speech in their stories and writing descriptively. On Thursday, we had a big class read out where the children got to share their stories with one another.



In Science, the children carried out an experiment to learn about the digestive system. They used bananas and biscuits to represent food, water to represent the saliva and fresh orange to represent the stomach acid. Then, using a sealable bag to represent the stomach and their hands to represent the stomach muscles they mushed it together. After, they put the food into a stocking which represented the small intestine. Next, they squeezed all of the food through allowing the nutrients to flow into the tray below which represented the body. Then, with the hard waste left they cut a hole in the stocking and transferred it into a paper cup with a hole in the bottom which represented the large intestine and rectum. They finally pushed the waste out through the bottom of the cup to represent our POO! They definitely had lots of fun with this messy experiment.



Did you know?

Anger is sometimes referred to as a 'secondary emotion' or a 'masking emotion'. That's because as well as being a valid emotion in its own right, we can also feel anger as a response to other, more vulnerable feelings such as shame, loneliness, sadness, nervousness, embarrassment...or a combination of any of these, and the list could go on! Teaching young people to identify the feeling beneath the anger is an important part of teaching self-regulation.



Co-Regulation

Children and young people – particularly those who find self-regulation difficult – look to the adults in their lives to help them regulate strong emotions. The adult can do this by consistently modelling the desired tone and behaviour (i.e. not joining them in their anger!) and narrating what's happening and what needs to happen.

This explicitly shows them how to react and respond appropriately. The adult remains calm but engaged, continues to communicate with warmth, and ensures that predictable and consistent boundaries and consequences are in place so that children learn to recognise the



Feeling the Feeling

Anger can be unpleasant to feel – it can often seem easier to act on it, even though in the longer term this could make things worse. Learning how to tolerate an uncomfortable emotion takes practise. Encourage the child to take deep breaths and focus on the areas in their body where they feel the anger. This takes their attention to what they're feeling instead of why they're feeling it. Encourage them to continue breathing deeply, noticing what they feel without judging the feelings or trying to make them go away. After a while, if they notice any other feelings with the anger, ask if they can put names to the other feelings that are there.



Go-to Activities

Once children are able to identify the physical cues that tell them they're becoming angry, support them in identifying 'go to' activities that help them to feel calmer before it becomes a problem for them. Quite often this is physical activity – anything that gets the heart rate going. Favourite activities can also help, such as playing computer games. In a school context, this quite often needs communication and imagination! Having a 'squeeze ball', a scribble pad or an activity that occupies without raising stress levels, such as a word search, are ideas that have been used successfully.

Welcome to Octobers newsletter. This newsletter has been designed to support and advise parents and carers of both Primary and Secondary school children, and therefore trust your personal judgement to share what you feel will be relevant information with your child.

BE BRIGHT BE SEEN!!

Children and young people are often injured in road collisions simply because they are not easily visible. This becomes more of a problem during the autumn and winter months as heavy rain, fog and shorter daylight hours cause poor visibility. Be Bright. Be Seen is an annual Road Safety campaign which is promoted, nationally during the month of October, reminding all road users to look out for each other and to be safe.



The campaign highlights the importance of being seen on our roads, choosing reflective and fluorescent clothing or accessories when walking or cycling. Children and young people tend to opt for coats and jackets which are darker in colour. Wearing something bright or reflective is important, keeps us safe and is a great help to other drivers and road users. Cyclists should remember it is an offence to cycle in the hours of darkness without a front light, a rear light and a red rear reflector.

It is worth noting that statistics show that child pedestrian road collisions are more likely to occur between the hours of 3:30pm and 4pm. Parents are encouraged to let their children visit the Department for Transport website which combines road safety information with interactive games https://www.think.gov.uk/education-resources/

With just a small Hi Vis accessory your child/s become more visible to other road users. Make it fun too and consider the use of Glow Sticks!




The Dangers of Vaping

Could your child be vaping? There has been an increase of children and young people being seen across the county vaping while out and about with friends and further research shows a lot of children considering vaping due to curiosity and peer pressure.

It is important to understand the risk to health and the path to addiction if not openly addressed with our families. Vaping hasn't been around long enough for us to know how it affects the body over time, but vaping could cause the following health issues.

- Slow brain development in children & young people
- Affects memory, concentration, learning, self-control, attention, and mood
- Increases the risk of other types of addiction as adults e.g. smoking
- Unknown toxins released into the body



Parents should also be aware that it is illegal to sell e-cigarettes to anyone under the age of 18. If you discover that your child is using them, it may be worth finding out where they're purchasing or getting them from. If a child is buying the products from a shop, parents may wish to remind the shopkeeper of the law and/or report the retailer to the trading standards department of their local authority. While it may be difficult to stop or prevent your child from smoking, remind them of the health implications and that they're breaking the law.



OUT WITH STRANGER DANGER IN WITH CLEVER NEVER GOES



Since it was introduced in the 1970's, the 'stranger danger' message has been fundamentally flawed. Most strangers will help rather than harm a child, and many people that do pose a risk to children are not strangers. Furthermore, it demands that all strangers should be treated with suspicion, which breeds fear in our communities. This has led to children spending less time outdoors, fuelling a rise in obesity and mental health problems. Add to this, children are spending more time online, increasing their risk of being groomed. Now is the time for a new approach that creates safer, happier and healthier children.

The CLEVER NEVER GOES rule means children shouldn't go anywhere with anyone - even if they know them - if it hasn't been agreed in advance by a parent or guardian. And please remember, children learn through repetition so make sure you remind them regularly of CLEVER NEVER GOES when they're going outside or online.

THE RULE:

If anyone asks you to go - even someone that you know - if it hasn't been agreed, remember: **CLEVER NEVER GOES**

Marshall Skills Academy awards 50 schoolchildren with new football kits after skills challenge success

A group of 50 schoolchildren from St Laurence Catholic Primary School, in Arbury, have been awarded new football kits by Marshall Skills Academy as part of a special site visit to Marshall's headquarters.

The Year 6 pupils, aged 10-11 years old, were awarded the football kits after accepting - and winning - a special skills challenge set by Marshall Skills Academy General Manager, Dan Edwards.

He challenged the pupils to break the current record of Marshall Skills Academy's 'nut and bolt' test – a manual dexterity test which the Academy uses to assess potential apprentices. If the pupils succeeded, Dan Edwards pledged to supply them with branded football kits.

Rising to the challenge, the Year 6 pupils were determined to work hard and beat the record, which they did.

Keeping his promise, Dan Edwards duly invited the pupils to Marshall's headquarters at Cambridge City Airport to enjoy a tour of its hangars and be presented with their prize.

"For us, this visit is about more than just giving the pupils new football kits," Dan Edwards said. "We want to show them all the possibilities for future careers in STEM that are waiting just around the corner from where they live, and we hope that it will inspire them to one day apply to our world-renowned engineering apprenticeship programme."

The site visit follows a partnership between Marshall Skills Academy and Cambridge United Community Trust (CUCT) that delivered a STEM workshop to pupils earlier this year, as part of CUCT's Aspirations project.

The session marked the start of a six-week programme aimed at primary school pupils across Cambridgeshire designed to inspire them to think positively about their future careers and expand their horizons.

CUCT uses the power of sport, especially professional football, to inspire young learners. Its Aspirations project helps pupils identify potential career paths they may wish to pursue in the future, as well as suggesting ways to develop new skills.

Tim Walker, Head of Education and Skills at CUCT, said: 'Since partnering with Marshall in September 2021, this project has been delivered to over 240 pupils in four local schools. Feedback from teachers and pupils has been overwhelmingly positive, with teachers identifying the project as a fantastic transition tool for their pupils. In the upcoming academic year, we are hoping to expand our delivery across a range of new schools, inspiring a wider range of young people to consider their own aspirations for the future.'

Dan Edwards added: "Marshall has always been committed to supporting social mobility within the local community and helping to raise the aspirations of the young people who live in it. I was personally inspired by the tenacity and enthusiasm demonstrated by the pupils at St Laurence Catholic Primary School, who got stuck into all the STEM activities and clearly also loved their football."

Commenting on the visit to Marshall's headquarters, Simon Pepper, a teacher at St Laurence Catholic Primary School, said: "This opportunity to visit a huge and multi-faceted working organisation such as Marshall was an incredible experience for our children. It gave each of them a real experience to remember, and the new football kits will excite the children and give them a renewed sporting spirit at St Laurence, especially at the beginning of our new school year."
